Minutes of the Building and Lands Committee Meeting held September 7, 2021 at 7:05 P.M. A-21-31 Great Lakes Property Development, LLC is proposing to develop a portion of parcel 05-00-044-000-096 on Rice Industrial Parkway for the development and construction of a shop/warehouse for use by North Coast Design Build. The general development plan for submitted and approved b the Planning Commission on 8/25/21. The final development plan and lot split will be submitted to the Planning Commission for review upon full approved of the I-1 District Board of Review pursuant to section 1141.07 of the ACO

Mr. Jeffreys spoke to this item and this item went through the Planning Commission unanimously. Mr. Cloud of North Coast Build Design explained the business. He stated they have built in Amherst previously. This will be for storage of building equipment. He said the building engineering has been submitted. Mayor Costilow added about the previous projects this company has done in town. He also explained Council's part of the Industrial Review Board and the need for emergency.
