MEETING WAS HELD IN HYBRID FORM (Council members and visitors in Chambers and all others via ZOOM)

Amherst City Council was brought to order in a Regular Session with President Wasilk opening the meeting at 7:00 P. M. Also present in Council Chambers were Ms. Smith, Mr. Heberling, Mr. Janik, Mr. Winiarski, Mr. Dembinski, Mr. Cowger, Mr. Wachholz, Treasurer Ramsey, Income Tax Secretary Laura Kemp, and Mayor Costilow. Present via ZOOM were Law Director Pecora, Assistant Law Director Ward, and Auditor Pittak. Mr. Jeffreys was excused per a motion by Mr. Dembinski and second by Mr. Cowger as he had a letter on file. Voice vote 7-0 to excuse. Also present were Mr. Ben Cutler, Public Affairs Manager from Columbia Gas of Ohio, and a reporter from the Chronicle.

The prayer was invoked by Chaplain Janik, followed by the Pledge to the Flag led by Sgt. At Arms Dembinski.

Consent Agenda: The Clerk read the Consent Agenda: Mr. Heberling motioned to accept the Consent Agenda as read. Seconded by Mr. Dembinski. Voice vote 7-0 to accept the Consent Agenda as read.

Acknowledgement of the Public pertaining to items on the Agenda: Mr. Ben Cutler – Public Affairs Manger, Columbia Gas of Ohio spoke and presented the 2023 projects that will be done in the City this upcoming year. He distributed information. He spoke to the projects in various locations in the city and how they work with the City. He answered questions asked by Council and administration.

Treasurer Ramsey spoke to A-23-05 and answered questions that were asked at the committee meeting. An information sheet had been distributed to council prior to this meeting. He said the total amount of funds needed for this position is \$7,667. There were many questions and a lengthy discussion about this request. This legislation provides for help in the office for one year only.

Mrs. Laura Kemp also explained the help that she needs in her office and what the additional employee will be doing. She answered questions.

Mayor Costilow had no opinion on this particular ordinance.
