MEETING WAS HELD IN HYBRID FORM (Council members and visitors in Chambers and all others via ZOOM)

Amherst City Council was brought to order in a Regular Session with President Wasilk opening the meeting at 7:00 P. M. Also present in Council Chambers were Mr. Dembinski, , Mr. Wachholz, Ms. Smith, Mr. Heberling, Mr. Janik, Mr. Winiarski, and Mayor Costilow. Present via ZOOM were Law Director Pecora, Treasurer Ramsey, Assistant Law Director Ward, and Auditor Pittak, Safety/Service Director Jeffreys and Morning Journal reporter Lauren Hoffman. Mr. Cowger was absent and had a letter on file. Mr. Dembinski motioned to excuse Mr. Cowger as he had a letter on file. Seconded by Ms. Smith. Voice vote 6-0 to excuse Mr. Cowger.

The prayer was invoked by Chaplain Janik, followed by the Pledge to the Flag led by Sgt. At Arms Dembinski.

Consent Agenda: The Clerk read the Consent Agenda: Mr. Heberling motioned to accept the Consent Agenda as read. Seconded by Ms. Smith. Voice vote 6-0 to accept the Consent Agenda as read.

Acknowledgement of the Public pertaining to items on the Agenda: There was no one speaking.

(g) An Ordinance authorizing and directing the Safety Service Director to solicit bids for the OPWC State Issue I (Round 36) Middle Ridge Road Improvements Project and award the contract for such work to the lowest responsive and responsible bidder; and declaring an emergency. (A-23-20)

Mr. Dembinski motioned to suspend all Council rules so that this may be passed in its first reading. Seconded by Ms. Smith. Roll call vote 6-0 to suspend rules. Mr. Janik motioned to adopt. Seconded by Mr. Dembinski. Roll call vote 6-0 to adopt. Becomes 0-22-21.

(h) An Ordinance establishing the salaries of the members and secretary of the City of Amherst Civil Service Commission, repealing all ordinances in conflict herewith, and declaring an emergency. (A-23-21)

Mayor Costilow noted there are two blank spaces that need to be filled in, and he suggested that to keep from having the same issue as we are having now of no raises for 30 years, that this Ordinance be edited to be the same as AFSCME contracts for the same percentage of salary increases as AFSCME receives. Mr. Winiarski motioned to amend this ordinance that the Civil Service Commission members are to receive the same salary increases percentages as do AFSCME members. Seconded by Mr. Heberling. Law Director Pecora noted that the correct verbiage will be inserted. Roll call vote 6-0 to amend the ordinance. Mr. Dembinski motioned to pass this on to its second reading as amended. Seconded by Mr. Wachholz. Roll call vote 6-0 to pass to second reading as amended.

But it's very important for their retentions so the overflow. can get back to the Creek.
