The way A-23-37 is currently written, it says that in 2026 the salary becomes the average of OPBA and AFSCME contract increases. If you look at the Law Director's proposed ordinance in Section 6, it says that it's further found that it provides that the Mayor shall be the chief negotiator for the City of Amherst. So he would like to see this changed so it's not the combination of contracts so we don't have potential issues in the future. Council is also pegged to receive on OPERS credit and that is actually set at 1.75% credit per year. So per this, he motioned that for 2026 and beyond, it will be a 2% raise. Mrs. Wasilk then he is saying to delete the verbiage about the" Average of OPBA
