Amherst City Council was brought to order in a Regular Session with President Wasilk opening the meeting at 7:00 P. M. Also present in Council Chambers were Ms. Harmych, Mr. Wachholz, Mr. Nahorn, Mr. Janik, Mr. Heberling, Mr. Winiarski, Mr. Dembinski, Treasurer Ramsey, Mayor Costilow, Law Director Pecora, and Auditor Phillips. Reports of the Administration:

Auditor Phillips: Their office is working on W-2 forms and working with the Mayor preparing the 2024 Budget. The December 2023 report had been distributed.

Treasurer Ramsey. The December 2023 report was distributed.

Law Director Pecora: No report

Mayor Costilow: Reported that we just received another request from ODOT such as the one we adopted this evening. He spoke to the self-contractors working in the public right of ways. mostly fiber optic work. They all have the right of way use agreements. They are in contact with homeowners if they suspect sprinkler systems. If there is any damage to yards, they can contact our office if they can't reach the company. He spoke to the Quarry Creek Subdivision and noted that there will be a public hearing on this on February 15, 2024. This will be the first test of the ordinance council passed about public notices. Notifications will be sent to the neighbors that abut or are contiguous to that property. Then it will be in front of Council for the final approval for that PUD district. He will get that packet to Council as soon as he can. He spoke to the planned power outage for this coming Sunday morning at 7:30 a. m. This will affect all the residents and businesses in the City. He explained further of the changeover The outage is necessary to safely energize the Woodings Substation and complete the interconnection to American Transmission System, Inc.'s (ATSI) existing Beaver-Black River 138-kilovolt (kV) transmission line. The outage is part of an expansion project to increase reliability to Amherst electric customers. The expansion of the Amherst #2 Substation, renamed the Woodings Substation, includes the addition of a 138-kV transformer and is part of a project to enhance the electrical efficiency, reliability and flexibility for all of Amherst's residents and businesses. He answered questions posed by Council.

Mr. Heberling motioned to accept the reports of the administration. Seconded by Mr. Nahorn. Voice vote 7-0 to accept the Reports of the Administration.
