Amherst City Council met in a Regular Session under full compliance of State Law with President Wasilk opening the meeting at 7:00 p. m. Roll call Mr. Nahorn, Mr. Janik, Mr. Heberling, Mr. Winiarski, Mr. Dembinski, Ms. Harmych, Mr. Wachholz, Also present were Mayor Costilow, Safety/Service Director Jeffreys, Treasurer Ramsby, Law Director Pecora, and Auditor Phillips. Also present were Mrs. Sandy Kaiser, Executive Director of the Amherst Historical Society, and members Mr. Jerry Gach, Mr. Todd Standen and Mrs. Pat Standen.

The Prayer was invoked by Chaplain Janik, which was followed by the Pledge of Allegiance to the Flag led by Sgt. At Arms Dembinski.

They have something coming up this weekend that is very unusual. She spoke about the Taste of History being held Friday June 14 and Saturday June 15. This is the second time for this event.
