Amherst City Council met in a Regular Session under full compliance of State Law with President Wasilk opening the meeting at 7:00 p. m. Roll call: Mr. Janik, Mr. Heberling, Mr. Winiarski, Mr. Dembinski, Ms. Harmych, Mr. Wachholz, Mr. Nahorn. Also present were Mayor Costilow, Safety/Service Director Jeffreys, Law Director Pecora, Assistant Law Director Ward, and Treasurer Ramsey. Auditor Phillips was absent and had a letter on file. Mr. Dembinski motioned to excuse Auditor Phillips as she had a letter on file. Seconded by Mr. Heberling. Voice vote 7-0 to excuse Auditor Phillips.

The Prayer was invoked by Chaplain Janik, which was followed by the Pledge of Allegiance to the Flag led by acting Sgt. At Arms Nahorn.

Consent Agenda: The Clerk read the Consent Agenda. Mr. Heberling motioned to approve the Consent Agenda as read. Seconded by Mr. Nahorn. Voice vote 7-0 to approve the Consent Agenda as read.

Acknowledgement of the Public pertaining to items on the Agenda: There was no one speaking.

Mr. Dembinski motioned to adopt. Seconded by Mr. Nahorn. Roll call vote 7-0 to adopt. Becomes 0-24-43.

Auditor Phillips: Not present

Law Director Pecora: No report

Safety/Service Director Jeffreys: No report.

Mayor Costilow: Spoke about the bidding on the old Office on Aging as per Council's approval. The advertisement has been in the newspapers for five weeks and the bidding will be held this coming Wednesday (13th) in Council Chambers. He spoke about the leaf pickup and said it is going extremely well. They will continue going from one side of town to the other until the snow comes. The worrisome subject is the City's agreement with ODOT on the Rt. 2 maintenance. For 60 years when the street came into being, the State of Ohio and the agreement was signed and the agreement was a big part of that. That agreement has been honored for 60 years. There is no expiration date on that agreement. They are saying that there is no longer an agreement and refuse to maintain that area or Rt. 2. We have been in contact with them, have filed some documentation and have filed some lawsuits, on of which says they must continue until this is settled. We have offered, even if we lose this in court, to make payments. ODOT turned that generous offer down. The snow is coming, and we don't have a facilities as a city to take care of that portion of the road. ODOT should stay with their agreement until a court tells us otherwise. Mr. Pecora said we filed a motion for preliminary injunction, or injunctive relief, which means, pending the outcome of the lawsuit itself, at least temporarily, ODOT will follow through with their obligations per the ordinance and the contract we agreed to. It's indicating that we would be irreparably harmed; that we don't have the means or ability to perform the snow removal or deicing. We have not heard back from the court yet. It is very important and if anyone out there that might have some pull, would put in a good word for us. Mayor Costilow said he hopes that ODOT comes through and does their job at least until the courts make a decision. Cautioned everyone to be careful on that street if/when it snows.

Mr. Nahorn motioned to accept the Reports of the Administration. Seconded by Mr. Wachholz. Voice vote7-0 to accept the reports.

Acknowledgement of the receipt of the November Auditor and Treasurer reports:

Mr. Dembinski motioned to acknowledge the receipt of the October Auditor and Treasurer Reports. Seconded by Mr. Wachholz. Voice vote 7-0 to acknowledge the receipt of the reports.

Mr. Heberling motioned to adjourn. Seconded by Mr. Wachholz. Voice vote 7-0 to adjourn. The meeting was adjourned at 7:16 p.m.
