PRIOR TO THE BEGINNING OF MEETINGS, MR. PETE STMATIS (WHO IS ON THE AMHERST FIRE DEPARTMENT FORCE) WAS HONORED FOR HIS BRAVERY AND SELFLESSNESS AS HE WENT ABOVE AND BEYOND THE CALL OF DUTY ON THE OHIO TURNPIKE WHEN HE WITNESSED A VEHICLE CRASH INTO THE MEDIAN WALL OF THE OHIO TURNPIKE LEAVING TWO PASSENGERS AND THEIR DOGS TRAPPED IN THE DISABLED VEHICLE. RECOGNIZING IMMINENT DANGER BY ONCOMING TRAFFIC, HE STOPPED HIS VEHICLE AND TOOK DECISIVE ACTION BY ASSISTING THE DRIVER TO SAFETY, THEN RETURNING TO RESCUE THE INJURED PASSENGER, THEN THE TWO DOGS. MERE MOMENTS AFTER THE RESCUE, A SEMI-TRUCK TRAVELING AT HIGHWAY SPEEDS COLLIDED WITH THE CRASHED VEHICLE WITH TREMENDOUS FORCE. THE GRAVE PERIL HAD EXISTED FOR THE PASSENGERS JUST SECONDS BEFORE AND HIGHLIGHTED THE LIFESAVING IMPACT OF PETE STAMATIS' HEROISM.

MANY FIREMEN, INCLUDING AMHERST FIRE CHIEF BRANDON DIMACCHIA AND MANY POLICE OFFICERS. INCLUDING CHIEF MARK CAWTHON, WERE PRESENT FOR THIS HONOR, ALONG WITH PETE'S FAMILY AND FRIENDS.

MAYOR COSTILOW READ THE PROCLAMATION WHICH WAS THEN PRESENTED TO MR. STAMATIS. THERE WAS A STANDING ROUND OF APPLAUSE FROM ALL PRESENT.
