The City of Amherst has determined the 2020 Road Program consisting of the rehabilitation of the following roadways:

## Asphalt and Concrete Pavement Rehabilitation and Infrastructure Improvements

- 1. Habant Drive 1,670 LF (North Main Street to Beverly Drive)
  - Existing asphalt to be resurfaced with asphalt including full depth repairs and curb repairs.
- 2. Beverly Drive 365 LF (Private Drive north to the end of the public street)
  - Existing asphalt pavement to be resurfaced with asphalt including repairs.
- 3. West Street 1,250 LF (Elyria Avenue to Maple Street including intersections)
  - Existing asphalt pavement to be resurfaced with asphalt including pavement repairs and curb repairs.
  - Storm sewer reroute and replacement between Crosse Avenue and Elyria Avenue.
- **4.** Crestline Avenue 1,710 LF (North Lake Street to West Martin Avenue)
  - Existing concrete to be overlaid with asphalt including pavement and curb repairs.
  - o Intermittent storm sewer improvements.
- 5. Intermittent Asphalt Repairs, Intermittent Concrete Repairs and Crack Sealing on Various Roadways throughout the City Approximately 6,000 LF
  - Locations to be determined.
