A-20-20 Allow the Safety/Service Director to enter into a contract for engineering and construction to make emergency repairs to the Crownhill Avenue Beaver Creek crossing; with emergency

Mayor Costilow spoke to this project and explained why and how the bidding process could be bypassed.

Mr. Appell explained the project and how it came to be an emergency. There is a sink hole that needs quick attention. He and Mayor explained how bad this situation could become if not taken care of.
